


Opportunities










Program Enrollment by Number



PROGRAM Highlight

Since the inception of JSS in 1984, the goal has been to provide the best possible education to our students. To quote a JSS parent, "JSS changed our lives—not just my daughter, but our whole family. It is amazing to see an entire school embrace your child and love them unconditionally."

These times have proven both challenging and inspiring for The Joseph Sams School, and while this school year looks unlike any other in our past, we are encouraged every day by the amazing spirit of our students, families, staff and community. The pandemic may have put the world on pause and required several modifications to what we consider normal, but be assured it did not stop our staff and students – JSS has remained strong and committed.

The hard-work and efforts the teaching staff continues to put forth to ensure a safe learning environment while maintaining high expectations is awe inspiring. Our staff truly understand the unique and often complex needs of our students, and have continued to focus on program and curriculum expansion and enhancement.

More than ever, it is critical to make sure the JSS frontline heroes have the right tools and support to continue to provide quality programs and therapies. Over the past year, we have enhanced our school-wide curriculum, Unique Learning System (ULS), by adding a new component, Positivity: Empowering Self-regulation. Offering proactive strategies for behavior management and empowering students to self-monitor and regulate their behaviors. In addition, a Physical Therapist (PT) Consultant has joined our staff, thus, allowing us to offer the Ready Body Learning Minds Program and adaptive physical education to our students. We are proud to share these program enhancements, as they continue to ensure we are providing the right educational environment and opportunities for students.

At JSS, we recognize that the journey is different for every student and family. However, one factor remains the same for all, and that is to provide a nurturing learning environment that champions what is possible for every student to grow and develop their full potential. Now, in our 37th year of operation, we remain most grateful for the courageous group of founding parents and their vision for their preschool-aged sons, which led to "The Early Years"; what we now call The Joseph Sams School.





Spotlight

Daniel Thompson

On June 19, 2014 we held 22 month old Qiumeng for the first time in Beijing, China. That was the day he became our son. We named him Daniel Charles Qiumeng Thompson. We knew Daniel had special needs. We knew he was a treasure from the Lord. And that is all we knew. When people asked if we were ready, the answer was "no." Not that we didn't have a medical plan, but no one can honestly say they're ready to parent. We weren't ready, but we were resolved. We resolved to embrace the future as an adventure believing that endurance develops through faith, determination, and consistency over time. We floundered through his first year home, but at the same time getting to be his parents was a dream realized (Daniel is our second of now four children). Wading through malnourishment, the process of attachment, surgeries, and hours of therapy almost daily during his first year home developed our "advocacy-muscle" and ability to somewhat communicate the loss and physical suffering he had endured.

We experienced the grief and glory of seeing almost all of his "firsts" over the next twelve months. By Daniel's third birthday, he shined. He was our smiley, healthy little boy...at home. For a season, we celebrated the fact that we got to be his safe haven with little regard for the many challenges he would face down the road. Then with Daniel happy and healthy, we sought further evaluations to determine a "road map" for raising him. Daniel's most prominent disorder severely affected his receptive and expressive language as well as his ability to self regulate. Daniel was capable of so much, yet he seemed lost within himself. Though we celebrated all of his breakthroughs, there remained what felt like a wall between Daniel and the rest of us because we lacked the means to communicate with one another.



We found in The Joseph Sams School the opportunity for Daniel to receive the tools for language and life skills he needed to thrive in the world and help us to draw closer to each other as a family. JSS provided Daniel with intensive instruction in these areas from fall of 2018 through last spring. What irony that I don't have the language to explain what was gained and how his growth impacted us! We have to settle with just saying "Thank you" knowing that's not enough. Daniel was given the gift of language! And not just Daniel, but we as a family were given the best methods of communicating with him. How do you measure the value of that!? JSS didn't just embrace Daniel as a student (which would have been enough). The instruction Nathan and I received was of equal value. Furthermore, in addition to a comprehensive Individualized Education Plan, JSS was a place where Daniel was loved and belonged.

Today Daniel is still our treasure; he still has special needs; and we are still building endurance. Our time with JSS opened doors, however, for communicating and completing daily tasks which empower us to move forward in this adventure. Daniel knows that the world can in fact be scary, that the future can be unpredictable, that life will be challenging, but he is not helpless or alone. He has a family, a community, and now (because of JSS) a VOICE. Those truths mixed with his Godgiven abilities will unfold into a bright future, one opportunity after another! And he himself will get to tell the world his story.

Peter Cook

Every parent remembers that moment when they first learn they are going to be a mom or dad, anticipating an amazing journey to care and love for another human being and give that child every opportunity possible. Whether a typical child or one with special needs, we all want the best life has to offer for our child and for he or she to be happy. That is what we have always hoped for our son Peter.

Our fourth and youngest child Peter was born with Trisomy 21, or Down Syndrome, almost sixteen years ago. We had an ultrasound and amniocentesis prior to his birth and so we were aware of his diagnosis before he was born. That said, nothing can prepare you for the many unknowns that come with a diagnosis like that. Not long after Peter was born, the neonatologist sat down with my husband and me. He said "I have good news, and I have bad news." I remember sitting terrified, not knowing what was before us. He said, "The good news is Peter will eventually do everything that his siblings can do. "What is the bad news? "He will never be as tall as you and your husband." It might take longer, sometimes months, sometimes years, but our tough Peter will get there given the opportunity.

When Peter was almost three years old and getting ready to finish with the Babies Can't Wait program, we received a phone call from the director at The Joseph Sams School. They wanted to meet our son and tell us about the school. We came by and immediately loved it and could tell it was someplace very special. Shortly after, Peter started preschool three mornings a week. He would go to school in his pajamas and carry his very own backpack that was as large as he was. Not only was he learning letters and academics, but also daily skills like undressing and dressing himself, grooming, and feeding skills. His speech improved because problems were identified and worked on. He made friends and learned social skills like taking turns and standing in line. We were thrilled. We also became friends with the other parents in Peter's class, providing much needed support.

A few years later we began to wonder what the public school system would be like. Peter had three older siblings in the system and we wondered if it would be a good fit for him. We had several discussions with the JSS administration and his teachers and decided to give it a try. The first year or two went well. Peter was soon diagnosed with a Sensory Processing Disorder and had dropped even further behind in his speech. The school he was attending was no longer the best fit for Peter and after looking at our options, Peter returned to JSS as an elementary student.

This transition was such a blessing for Peter! Our son was learning and working hard. Peter was transitioning better and the school was teaching him to make good choices. Peter was eating in the cafeteria with his friends. He participated in music and art class. He went on field trips and out on community based instruction. He was happy and thriving! But the big success was that Peter was learning to communicate using words and sign language to express his emotions and desires, therefore cutting down on many of the behavior issues that came with his inability to communicate.

Over the last three years unexpected medical challenges have occurred in Peter's life. He had three separate surgeries to rebuild both hips and then learned to walk again. The teachers and staff have been so flexible with his many absences, provided materials for home study, and even visited him at home! We have also found resources through talking to staff and parents at the school that have aided in Peter's recovery.

Our son is now in the Upper School at JSS and continues to grow. His days may not be perfect, but the goal is to be happy and successful. His teachers have found what motivates Peter and are able to help him meet his goals. He is now learning job skills in the community and it has opened a whole new world for him. If we are having an issue at home, whether behavioral, with speech or communication, or with daily skills, his teachers are willing and able to help with it. The staff partners with us to help him reach his potential. The focus at the school is not on Peter's handicaps, but what he can and has yet to do. It is just like the doctor long ago told us. It has been a difficult but joyous journey so far, and we watch daily as Peter learns to overcome obstacles and work hard to be successful.

Looking forward we know we are in the perfect place to provide great opportunities of learning for Peter. He is happy, challenged, and is working hard to meet his goals. He has friends and is participating in activities that keep his life full. There is a big world outside of The Joseph Sams School and they are doing a great job preparing Peter for it. We do not know what the future holds, but we are so glad this is where God has put us right now.

The Joseph Sams School once again extends a heartfelt appreciation to the foundations that so graciously supported the school throughout FY2020. Our loss of fundraising event revenues due to the pandemic coupled with the costs involved to safely reopen the school in August created an unprecedented need for funds to support daily operations. We are extremely appreciative of those foundation that have so willingly contributed to this critical area of need. The John and Mary Franklin Foundation granted \$10,000 and The Ekkebus Charitable Fund provided an additional \$5000, both supporting general operations and aiding JSS in its efforts to provide a safe and secure facility in which to house our unique programs and services.

JSS continues its long-term commitment of providing scholarship assistance to qualifying families making it possible for parents to access the quality programming their children so desperately need to advance in development. Many children simply would be unable to attend JSS without this assistance. We express our gratitude to **The Pennies From Heaven Foundation** for its \$20,000 gift to fund student scholarships and **The William R. and Sara Babb Smith Foundation** for once again providing \$20,000 to aid students from Henry County.





In order to provide the best possible education for our students, we are continuously seeking ways to enhance our programs and curriculum. **The Frances Wood Wilson Foundation's** gift of \$10,000 allowed JSS to provide a new component, Positivity, to our existing curriculum. Positivity is a researched-based curriculum that provides a proactive student-centered approach to self-regulation and social skills. Both proficiencies are vital for our students' success!

Revenues to support capital needs are always needed and welcomed! Fayette Coweta EMC generously gifted JSS \$50,000 for the purchase of a new school bus. The bus is used daily to transport students to local community venues and businesses as part of their Vocational and Community-based Instruction. As we continue our efforts to secure capital funds for the construction of a new facility, we were thrilled to receive gifts in the amount of \$20,000 from The Pennies From Heaven Foundation and \$10,000 from The Hart Family Foundation to further our capital campaign efforts!

The Oleta and Jimmy Collins Family Fund contributed \$29,000 to assist three of the above-mentioned areas of need: general operations; the future capital campaign; and scholarship endowment funds. We are grateful for the long-time support and generosity of the Collins family!

The Joseph Sams School strives for its students to become as independent and productive as possible aided by quality educational and therapeutic services. 
Since 2011, we have received over \$450,000 in scholarship revenues from The Apogee School Choice Fund which has allowed JSS to award 190 scholarships.
